

## Nanoparticles for nasal vaccination

### Abstract

The great interest in mucosal vaccine delivery arises from the fact that mucosal surfaces represent the major site of entry for many pathogens. Among other mucosal sites, nasal delivery is especially attractive for immunization, as the nasal epithelium is characterized by relatively high permeability, low enzymatic activity and by the presence of an important number of immunocompetent cells. In addition to these advantageous characteristics, the nasal route could offer simplified and more cost-effective protocols for vaccination with improved patient compliance. The use of nanocarriers provides a suitable way for the nasal delivery of antigenic molecules. Besides improved protection and facilitated transport of the antigen, nanoparticulate delivery systems could also provide more effective antigen recognition by immune cells. These represent key factors in the optimal processing and presentation of the antigen, and therefore in the subsequent development of a suitable immune response. In this sense, the design of optimized vaccine nanocarriers offers a promising way for nasal mucosal vaccination. @THELIBCOMMIE

## Hydrogel nanoparticles and nanocomposites for nasal drug/vaccine delivery

### Abstract

Over the past few years, nasal drug delivery has attracted more and more attentions, and been recognized as the most promising alternative route for the systemic medication of drugs limited to intravenous administration. Many experiments in animal models have shown that nanoscale carriers have the ability to enhance the nasal delivery of peptide/protein drugs and vaccines compared to the conventional drug solution formulations. However, the rapid mucociliary clearance of the drug-loaded nanoparticles can cause a reduction in bioavailability percentage after intranasal administration. Thus, research efforts have considerably been directed towards the development of hydrogel nanosystems which have mucoadhesive properties in order to maximize the residence time, and hence increase the period of contact with the nasal mucosa and enhance the drug absorption. It is most certain that the high viscosity of hydrogel-based nanosystems can efficiently offer this mucoadhesive property. This update review discusses the possible benefits of using hydrogel polymer-based nanoparticles and hydrogel nanocomposites for drug/vaccine delivery through the intranasal administration.

## Nasal vaccine innovation

### Abstract

The current vaccine market is gaining momentum in the development of alternative administration routes, namely intranasal, oral, topical, pulmonary, vaginal, and rectal; the nasal route offers the most promising opportunity for vaccine administration. It can enhance convenience, safety, elicit both local and systemic immune responses; thus potentially provide protection from pathogens at the site of entry. Nasal vaccine innovation comes with both opportunities and challenges. The innovative strategies used by industry and researchers to overcome the hurdles are discussed in this article: these include live-attenuated vaccines, adjuvants, mucoadhesives, particulate delivery systems, virus-like particles, vaccine manufacture, challenges of regulatory authorities, and the nasal vaccine impact on market potential. Critical issues for effective nasal vaccination are the antigen-retention period that enables its interaction with the lymphatic system and choice of an adjuvant that is nontoxic and induces the required immune response. Co-adjuvanting by means of a mucoadhesive technology addresses some of these issues. ChSys(\*), a natural bioadhesive with proven intranasal safety profile, has already demonstrated efficacy for several nasally delivered vaccines including norovirus. With the looming threat of a pandemic, alternatives such as intranasal vaccination will ultimately facilitate greater public compliance and rapid mass global vaccination.

**3. An implied consent process** by which parents are informed of imminent vaccination through social mobilization and communication, sometimes including letters directly addressed to the parents. Subsequently, the physical presence of the child or adolescent, with or without an accompanying parent at the vaccination session, is considered to imply consent. This practice is based on the opt-out principle and parents who do not consent to vaccination are expected implicitly to take steps to ensure that their child or adolescent does not participate in the vaccination session. This may include not letting the child or adolescent attend school on a vaccination day, if vaccine delivery occurs through schools.

# No lockdown for wealthy areas

Leaked emails reveal that wealthier seats and new Tory strongholds are being spared the harshest restrictions

Wealthy areas, including the chancellor Rishi Sunak's parliamentary seat, are avoiding lockdown despite having higher Covid-19 rates than poorer areas that are subject to restrictions, according to leaked emails between health officials.

The government is under growing pressure to explain why it has placed large parts of the north and Midlands under local lockdowns while overlooking areas with similar infection rates. Asked why the

northwest is "treated differently" from areas such as his own seat of Uxbridge and South Ruislip in west London, Boris Johnson said on Friday: "I appreciate ... people want to see an iron consistency applied across the whole country."

Matt Hancock, the health secretary, decides which areas to place in lockdown during weekly "gold" meetings. Yesterday 50 councils were subject to measures such as bans on household mixing. However, there is no official Covid-19 infection rate that triggers a lockdown.

On Thursday, Professor Dominic Harrison, the director of public health for Blackburn with Darwen, the largest borough in the wider Lancashire area, wrote to Department of Health and Social Care (DHSC) officials, saying the measures were "avoidably increasing economic inequality". He said: "There is now a different level of central control applied across local authorities, with some of the more economically challenged boroughs being placed into more restrictive control measures at an earlier point in


